Dear Mary Ann Winterling Elementary School Families, Students, Staff, and Community Members,

City Schools is committed to making sure that every school across the city provides our students with high-quality educational experiences that enables students to thrive, supports their learning and encourages their personal growth. Part of our work in reaching this goal includes an annual review of the district’s schools and programs that looks at a broad range of considerations, including academic performance, school climate, school programming, enrollment trends, conditions of school facilities, the range and balance of school options in different parts of the city, and the 21st Century School Buildings Plan.

I recognize that school year 2020-21 is complicated by the ongoing Covid-19 pandemic, the impacts of that pandemic on our communities, and the recognition of the ongoing injustices that impact the communities we serve, our staff and our work. We recognize that changes to school communities can be stressful for school communities. Therefore, this year’s recommendations are limited to actions that are part of the 21<sup>st</sup> Century School Buildings Plan or recommendations where postponing potential actions could cause greater harm than having the Board consider and act sooner on the behalf of our students.

**Tonight, based on the results of this year’s review, I am recommending that the Baltimore City Board of School Commissioners consider closing Lockerman Bundy Elementary School in June 2021, at the end of the current school year, consider rezoning students to Mary Ann Winterling Elementary School and expanding the Mary Ann Winterling zone to include the Lockerman Bundy zone with a zone correction, and consider returning the Lockerman Bundy Building to the city of Baltimore in summer 2021.**

Enrollment in the school community has been declining for several years and there are not enough students to sustain two separate elementary schools. Combining the two small elementary schools into one program will improve students’ chances for success by enabling them to attend a school with the capacity to sustain rich, robust, and varied educational programs.

If the closure is approved, the school communities would combine starting in the 2021-2022 school year, the Mary Ann Winterling zone would be expanded to include the Lockerman Bundy zone and adjusted so that the zone does not cross Route 40. Students on the north side of Route 40 would be rezoned to Harlem Park Elementary/Middle School starting in the 2021-2022 school year.

If approved and given the importance of the Lockerman Bundy school name and desire to maintain the history of schools, staff will work with the school community in figuring out how to honor and maintain the history of school name within the combined school as well as part of broader work to maintain the legacy of schools named after important persons, particularly those rooted in the history of our students and Baltimore and/or Maryland, in our portfolio of schools.

As a member of the Mary Ann Winterling community, your feedback on this recommendation is critical. **A virtual meeting will take place beginning at 5:30 p.m. on Tuesday, December 1**, where you can learn more and get answers to your questions. Details on how to join the meeting are at the end of this letter, will be posted on the district website and shared by your school leader.

**In addition, the Board is providing two opportunities for the public to give comments on all recommendations in the report of this year's review of schools and programs.** As City Public City Schools continues to fight the spread of COVID-19, all Board meetings will be held remotely in the interim. 

**The Board will vote on this recommendation at a meeting on Tuesday, January 12, 2021.** If the Board votes to approve closure of the Lockerman Bundy school program, district office staff will be available to meet with you to ensure that the transition process is smooth and meets students' and families' needs.
